



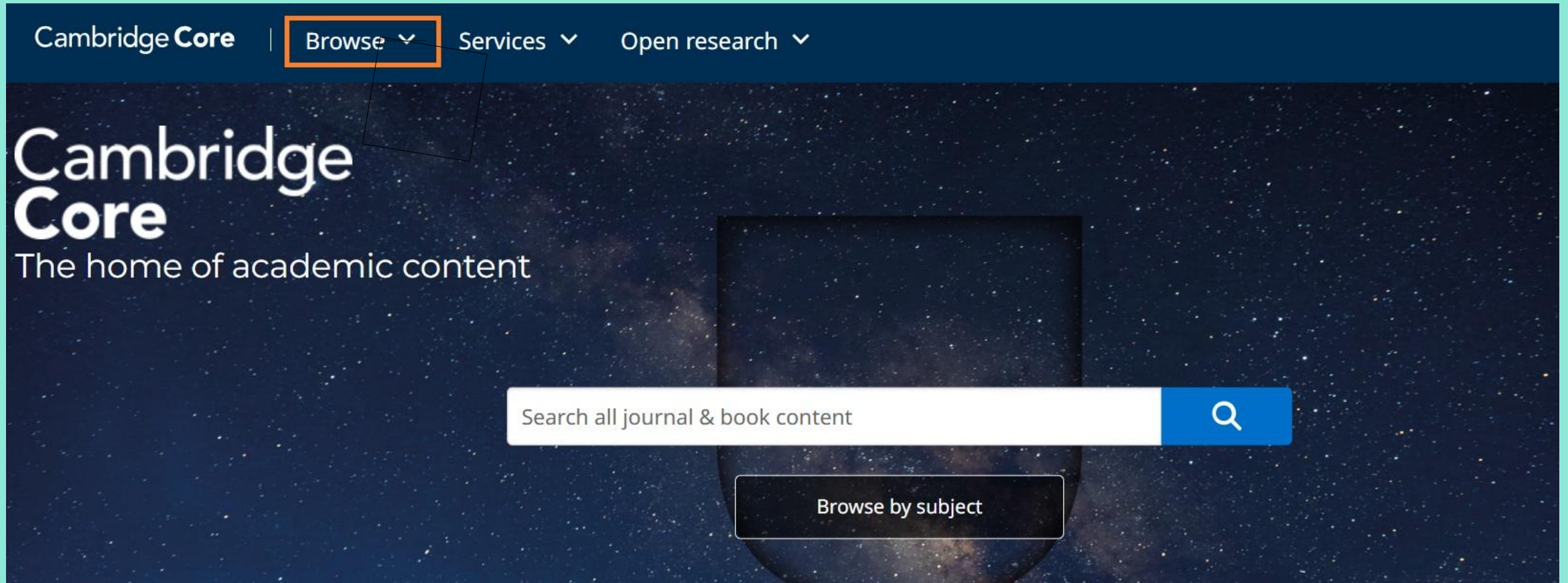

Initial submissions

For the initial submission please upload a PDF or MS Word file and select file designation "Main Document". All figures and tables should be embedded within the Main Document file. **Please note that file size limit for the main document and supplementary material must be 6MB or less.** The system will create a PDF proof from your main document, which will be used for the review process. You must view the PDF proof before the paper can be submitted. Movie files should be upload separately using the file designation "Movie". [The maximum number of movies files that can be submitted is 10 and each Movie file should not exceed 10MB.](#) The file designation "Other Supplementary Material" should be reserved for material to be published online only (data tables, etc.). This material will be made available to reviewers.

Graphical Abstract

We now require a small thumbnail size image to be publish in the table of contents on the abstract page. The graphical abstract should be a single eye-catching image without text, numbering, captions or borders. [Multiple panels/images will not be accepted.](#) The image should be aspect ratio 1.2:1 (8cm x 5cm (landscape)) and submitted in either gif or high resolution jpeg format (300dpi). If you do not have copyright to the image, then please ensure you have permission to reuse the figure. All graphical abstract images will be considered for the JFM cover.

Unless very large, vector graphics are preferred to ensure image sharpness regardless of sizing. If you do not have the copyright to the image, please ensure you have permission to reuse the figure. Captions are not required. Text is actively discouraged, but if it must be used, it should be legible in a small thumbnail (2.4cmx2cm) presented in the table of contents. All graphical abstract images will be considered for a JFM cover selection by the JFM Panel. Please note that we publish 24 covers in a year.

Submission of movies

Each movie should be uploaded separately and given the title Movie 1, Movie 2 etc. with file designation "Movie". Accepted formats for movies are .mov, .mpg, .mp4 and .avi. Each movie should be no more than 10MB. [Please also include a separate Caption list.](#)
