Regulations of University of Lucknow for Visiting Scholars /Researchers/ Professors

University of Lucknow shall allow faculty members of Foreign Universities or other qualified individuals, to affiliate with the University of Lucknow for carrying out research/ teaching at the university for a defined period ranging from a few weeks to one year as per approval of the Vice Chancellor.

Criteria for affiliation of Visiting Scholar /Researcher

- i. The individual must be visiting from, and having an ongoing affiliation with an academic or research institution or organization other than University of Lucknow
- ii. The individual must have a no objection certificate from their academic or research institution or organization.
- iii. The individual must take leave from the academic or research institution where he/she holds an appointment which, shall not be expiring prior to expiration of the affiliation at the University of Lucknow.
- iv. The individual must have a postgraduate degree/ doctoral degree/ recognized research-related expertise in his or her field.
- v. The individual must have a source of financial support from outside the University of Lucknow. The individual shall bear all his/ her expenses during their stay at University of Lucknow. In exceptional circumstances, the University of Lucknow may bear some or all of their expenses, subject to the approval by the Vice Chancellor.
- vi. The visitor must be proficient in English.

Criteria for the affiliation of Visiting Professor

- i. Visiting Professor shall include:
 - o Faculty from other academic institutions who are invited to University of Lucknow on honorary basis during a period of leave at their home institution.
 - o Qualified personnel from industry, government or other organizations (such as research institutes), including qualified retired faculty members from those institutions, who wish to visit University of Lucknow in an honorary basis.
- ii. The individual must have a source of financial support from outside the University of Lucknow. The individual shall bear all their expenses during their stay at University of Lucknow. In exceptional circumstances, the University of Lucknow may bear some or all of their expenses, subject to the approval of the Vice Chancellor.
- iii. The visitor must be proficient in English.

The scholars under both the categories shall travel to University of Lucknow campus at their own expenses, and shall make their own arrangements for accommodation and living expenses. The duration of their visit shall be approved by the Vice Chancellor.

Regulations of University of Lucknow

for

Providing one semester stay/ credit transfer to students of foreign higher education institutions

1. The University of Lucknow may provide one semester stay/ credit transfer to the students of foreign higher education institutions on approval by the Vice Chancellor.
2. The students enrolled in foreign higher education institutions can visit University of Lucknow for one / two/ more than two courses for a semester with prior approval from their institutions.
3. Both the institutions shall enter into an agreement for the purpose.
4. The proposed fee shall be US Dollar 300 per course per semester.
5. After the end of their courses, they shall receive credit transfer and related certification as per their performance.
6. The one semester stay/ credit transfer to the students of foreign higher education institutions shall be done through very careful mapping of courses so that credits earned at the University of Lucknow may be transferred to the parent University of the student. This mapping shall be conducted by both institutions prior to allowing the student to join any course at the University of Lucknow.
7. There shall be no overlap in the courses studied at both the institutions.
8. Before taking the courses, the student enrolled in foreign higher education institution shall sign an undertaking that he/ she has perused the course content and guidelines, and he/ she has agreed to take it for the partial fulfillment of the requirement of their ongoing degree programme at his/ her parent institution.
9. The rules /regulations of UGC and State Government /other relevant regulatory bodies shall be applicable in all such academic activities and credit transfers.
10. The individual shall bear all their expenses during their stay at University of Lucknow.
