



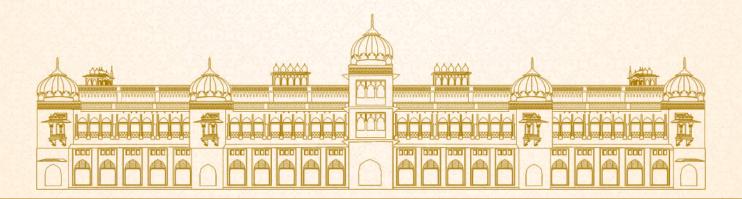

Inaugural Function

The National Summit of Institutional Leaders 2024 was inaugurated on February 15, 2024 in the Valmiki Mandap at Arts Quadrangle, University of Lucknow. The inauguration of this landmark event was done by Honourable Chief Minister of Uttar Pradesh, Shri Yogi Adityanath ji. He was joined on stage for the inauguration by Dr. Rajkumar Ranjan Singh, Hon'ble Minister of State for Education, Government of India, Shri Yogendra Upadhyay, Hon'ble Education Minister of Uttar Pradesh, Smt Rajni Tiwari, Hon'ble Minister of State for Education, Government of Uttar Pradesh, Prof. Kailash Chandra Sharma, National President, VBUSS and Prof. Alok Rai, VC, University of Lucknow.

The programme began with the lightening of lamp and obeisance to Goddess Saraswati. This was followed by introduction and felicitation of the dignitaries. Prof. Alok Kumar Rai, welcomed all the dignitaries to the University of Lucknow for NSIL-2024 and briefed them about the University and why the organization of NSIL-2024 at this institution was relevant and timely. He was followed on stage by Prof. Kailash Chandra Sharma, National President, VBUSS, who gave his opening remarks about the summit, stating its significance.

Shri Yogendra Upadhyay, Hon'ble Education Minister of Uttar Pradesh in his address raised the need to get together and discuss the various dimensions of education and the global need while conserving, strengthening and propagating our culture. He was followed on stage by Dr. Rajkumar Ranjan Singh, Hon'ble Minister of State for Education, Government of India. Dr. Singh spoke in length about the transformative nature of NEP, 2020 and its role in increase competence of individuals for development of Viksit Bharat.

Honourable Chief Minister, Govt of Uttar Pradesh in his inaugural address stated that educational institutions should not keep a distance from government welfare schemes and they should be made a part of the curriculum. He said that the youth have to be made not only educated but also knowledgeable. Educational institutions are providing education to the youth, granting degrees and certificates, but when the student exits the higher educational institution, they lack the knowledge of what to do next. This event at University of Lucknow serves as a platform to address that issue. He also said that we have a rich storehouse of Vedic knowledge, which can guide humanity towards a new path even today. - Need to identify individuals' hidden comparative advantages and promoting multidisciplinary education.
- The need to focus on the New Education Policy emphasis on multidisciplinary education and the importance of solving real-world problems at the interface of various disciplines.
- Brain drain and socioeconomic disparities need to be reconciled and addressed to enable students to explore their inner qualities and create their own identities.
- Parallels from ancient mythology illustrated the need for filling missing components in the education system addressed by NEP 2020
- Need to develop India by 2047 and increase gross enrollment ratio to 50% by 2035 through collective efforts of universities and colleges.
- Multi-disciplinarity is not new and has historically present in the Indian education system.
- The interchangeability of interdisciplinary and multidisciplinary terms and their historical practice in Nalanda and Taxila were discussed
- Need to tap new websites like Google Books, N Gram viewer and Google Trends facilitating innovation in research.

- o Outcome-based education and the need for periodic evaluation is essential
- Only 40% of 1168 universities have sought accreditation, with 75% holding valid grades under NAAC.
- o Binary accreditation system replacing NAAC to simplify accreditation status as accredited or non-accredited.
- o Emphasis on continuous improvement in ranking scores rather than maintaining positions, with online assessment only in exceptional cases.
- o Institutions progress through accreditation levels, aiming for global recognition at maturity level 5.
- A separate system for remote and rural institutions to ensure inclusive ranking approaches is the need of the hour.
- Inclusion of the Radhakrishnan committee in higher education for binary and maturity-based accreditation.
- Need for quality control and assurance, attributing 85% of quality problems to top management.
- Education aims to liberate individuals and can be achieved via technology integration in higher education.
- o Training faculty according to industry demands is crucial, with a growing gap between good and lacking institutions needing bridging.

- o Textbooks are available in regional languages at the undergraduate level across states, with Uttar Pradesh leading in Hindi book sales.
- Tamil Nadu and Karnatakaare good examples of states accepting education in regional languages
- o IGNOU's offers all undergraduate programs in the mother tongue from 2021.
- Creating a conducive environment for Indian languages in institutions and expanding their usage.
- Language options for examinations should be provided
- o UGC and NCERT are leading efforts in translating study materials
- Need changing perceptions around English language dominance, and to support multilingual learning and the Indianization of English.

- Educational institutions must emphasize holistic development through research and innovation, with emphasis on documentation of Indian knowledge systems and blending talent with technology.
- Increase in research funding post the Washington Accord, has led to a rise in India's global research contribution
- Traditional separation of education and research should be avoided and a more integrated approach must be used to foster worthy research.
- Culturally embedded research should be encouraged
- Research mandates should not be made compulsory on less equipped institutions, which could lead to malpractices.
- India should focus on problem-solving research rather than mere validation, highlighting the need for a scientific temper among researchers to lead India to global prominence.

- o Alignment of institutional curricula with workforce requirements
- o Skill development and integrating AI into education is essentail
- Workshops needed to enhance educators' capabilities and urged collaborative efforts among institutions, industry, and government, echoing NEP 2020's ethos.
- o Personal development alongside academic learning and interplay between society, industry, and institutions is key to non-linear growth.
- Essential to have rural perspectives in education and integration of industry collaboration to address real-world challenges.
- o Emphasized the need for a flexible framework and co-learning within society to foster holistic development.

- Diverse HEIs have diverse funding issues and one stop solution is not possible.
- Importance of equitable fund distribution and leadership-led innovative funding solutions.
- Financial innovations such as foreign student admissions, consultancy and societal funding.
- Need to increase the gross enrollment ratio and higher expenditure on higher education, citing reports from UNESCO and the World Bank.
- Sudden fee hikes should be avoided to prevent student burden, using Nalanda University as a model of free education.
- Balanced allocation of time for curricular, co-curricular, and extracurricular activities, suggesting variable fee structures and needbased waivers for affordability were discussed.
- o Recommended dividing states into economic zones for quality sustenance.
- Transparent governance and disclosure norms are essential to address trust deficits.
- Creation of vision documents, strategies, and action plans with clear milestones and deliverable outcomes for institutes.
- o Small steps are significant and expenditure should be rationalized and curriculum restructured to enhance fund management efficiency.

Valedictory

On February 17, 2024, the three-day NSIL summit concluded with a valedictory program at Valmiki Mandap in the Arts Quadrangle of the University of Lucknow. The event was graced by the honorable presence of Chief Guest Shri Rajendra Vishwanath Arlekar, Governor of Bihar, along with Prof. Narendra Kumar Taneja, General Secretary of VBUSS, Prof. Kailash Chandra Sharma of VBUSS, and the Vice-Chancellor of the University of Lucknow, Prof. Alok K. Rai.

The three-day National Summit of Institutional Leaders 2024 culminated on Saturday with the announcement of the Lucknow declaration 'Panchsutra' for development and growth of higher education.

The program commenced with the ceremonial lighting of the lamp, followed by a speech from Prof. Alok K. Rai. He emphasized the pivotal role of education in liberating individuals from limitations and highlighted Lucknow University's recent achievement of entering UGC Category I. The university's focus on education, society and industry, aiming to progress to industry 5.0 with a more human-centric approach, was underscored.

Prof. Taneja stressed the importance of students' spiritual development and praised the successful participation of Vice-Chancellors from 55 universities in the summit, which culminated in the creation of the Lucknow Declaration, encompassing crucial points.

Shri. Rajendra Vishwanath Arlekar, Governor of Bihar expressed his happiness for the invitation and foresaw a resurgence of old India with NEP 2020. "Such a summit would be a milestone in the growth and development of higher education institutes and such exponential development would contribute towards the holistic development of youth and the entire nation so that our country can lead the entire world as Vishwaguru," said Arlekar.

The Panchsutra declaration, released during NSIL-2024. advocates the concept of Samaj (society), Sahyog (support), Sudhar (improvement), Satata (continuity) and Sanskar (culture). In the declaration, the concept of 'samaj' suggested care of society and motherland and inclusive education aimed at social justice and aligning social and community needs. Under 'sahyog', the concept was of creating synergy through collaboration among institutions for research, knowledge and resource sharing and others.

The concept of 'sudhaar" included addressing inhibitors that impede progress, nurturing competence to ensure employability and develop entrepreneurship and actions like reducing bureaucratisation in academic affairs. The governance of regulatory bodies should adopt a bottom-up process of consultation and participation regulations should be light but tight, in accordance with NEP- 2020. The 'satatata concept focuses on environmentally sustainable, culturally sensitive and invigorating psychological and physical well-being. The concept of 'sanskar' advocated education for character building and holistic development.

Prof. Kailash Chandra highlighted the five points in the Lucknow Declaration, emphasizing collaboration as essential for the development and growth of higher education. The program concluded with a vote of thanks from Prof. Rakesh Dwivedi, Chief Proctor of the University of Lucknow and organising secretary of the summit.
