

#### CONCEPTNOTE

Women form the building stone of the family in particular and the society in general. Yet they are and have been subjected to vulnerability and coercion every now and then. In the fast pacing developing world, women have low share in utilizing the fruits of development and are high on being abused, maltreatment and undergo various forms of violence in different spheres of life. Violence against women (VAW) and girls is an all pervasive phenomenon leading to violation of human rights all over the world. It is an evil that knows no social, economic or national boundaries. It is estimated that, one in three women experiences physical or sexual abuse in her lifetime.

The United Nations defines violence against women as "any act of gender-based violence that results in, or is likely to result in, physical, sexual or mental harm or suffering to women, including threats of such acts, coercion or arbitrary deprivation of liberty, whether occurring in public or in private life." Female population buffers from many forms of violence that may include domestic violence (violence from an intimate partner and family members), rape and other forms of sexual violence, acid attack, early and forced marriage, economic control, coercion and emotional abuse, etc. The impact of violence directed at women ranges from immediate to long-lasting physical, sexual and mental consequences for women and girls, which at its worst level includes death. Violence also has a negative impact on individual women's livelihoods: the earnings of women in formal paid work who are exposed to severe partner violence are 60% lower than women who are not. It negatively affects the overall well-being of women and prevents their participation in society. Besides having negative consequences for women, the violence also affects their families, the community and the country at large. It also has tremendous costs, from greater health care and legal expenses and losses in productivity, to impacting national budgets and the overall development of the nation. Decades of civil society mobilization and women's movements along with various national and international attempts, have marked the gender based violence on the action front with provision for protecting and empowering women. Many a countries have made plethora laws of against domestic violence, sexual assault and other forms of violence, however, challenges continue in executing these laws, limiting women and girls' access to safety and justice. The attempts to prevent violence when it does occur are extremely poor and the culprits often go unpunished. More focused and joint efforts at individual, group, community and societal level are required to protect and prevent women from being victims of violence.

The proposed two day national conference is an attempt to bring into the forefront the ideas and suggestions of young minds, academicians, practitioners and resource persons and personnel/authorities associated with the framing/executing laws and policies from diverse fields that would help in paving way for the empowerment and protection of women saving them from violence and abuses.
