



Memorandum of Understanding (MoU)

Between

Experiome Biotech Private Limited, Lucknow

And

Institute of Pharmaceutical Sciences, University of Lucknow, Lucknow

MoU for Scientific and Academic Cooperation

Purpose

The purpose of this agreement is to promote cooperation in pharmaceutical education and scientific research between Experiome Biotech Private Limited and the Institute of Pharmaceutical Sciences, University of Lucknow, Second Campus, Jankipuram Extension, Lucknow, UP-226031.

Type of Cooperation

Through this memorandum, both parties affirm the value of international/national collaboration and agree to promote the following activities:

1. Joint research projects in the field of mutual interests;
2. Exchange of academic publications and reports, writing books/booklets jointly in the area of pharmaceutical sciences, or any other area of mutual interest;
3. Opportunities for students, faculty, and staff development and recharge;
4. Industrial training and placement of undergraduate students;
5. Include collaboration in setting up and upkeep of the relevant infrastructure in both the organizations and other activities as mutually agreed.

This agreement places no financial obligations or supplementary funding commitments on either party.

Terms

This agreement will become effective upon the date of signature by both the parties. It shall remain valid for 3 years from the date of the signature, with the understanding that it may be modified by written mutual consent of both the parties. This Agreement may be terminated by either party with the advance written notice of at least 30 days. Upon notice of termination, both Institute of Pharmaceutical Sciences, University of Lucknow, and Experiome Biotech Private Limited agree to work in good faith to enable visiting students to complete their respective training/research programs unhindered by the termination. The Agreement may be extended by mutual consent of the two parties after 3 years, and it must be renewed in writing.
