Whereas DEPTT has requested INTACH to undertake academic activity like training/workshop/internship programs in the field of conservation of paper manuscripts, books and other documents pertaining to library collections.

## AND

whereas, INTACH has represented that it is capable and possesses the requisite expertise to undertake academic activity like training/workshop/internship programs.

Now, therefore, this MOU witnesses and the parties hereto hereby mutually agree as follows:

- INTACH shall undertake academic activity like training/workshop/internship programs at INTACH Conservation Institute, Lucknow.
- INTACH shall provide a detailed proposal of the training/workshop/internship program.
- The work shall commence after signing of the MOU between the parties.
- The responsibilities of INTACH and DEPTT are as set out below.

## Responsibilities of INTACH

- a. INTACH shall provide a detailed internship program as per the syllabus provided by the Department.
- b. No working lunch and honorarium will be provided to the interns by INTACH.
- c. Internship certificates will be provided to the candidates after successful completion of the internship program. Any candidate absenting from the internship program will not be entitled for a certificate.
- d. The internship program will largely cover Preventive Conservation of library materials, storage of books, handling and transportation of books, binding of books or any other topic as suggested by the Department. The training program will also cover basic steps of Curative conservation involved in caring of the materials.

The Department shall provide a proper list of students/candidates along with authorization letters.

The Department shall permit the interns to travel to other sites of projects to learn.

Maximum 15 students can get an internship at INTACH, Lucknow.

DEPTT and the INTACH, hereby, mutually declare that the above responsibilities are acceptable.
