### **GENERAL INSTRUCTIONS:**

1. **Age limit** – 21 to 40 years as on 01-07-2024 (upper age limit for reserved category candidates shall be relaxable as per U.P. Govt. rules).

2- **Pay Matrix-** Rs. 15,600-39,100/- Grade pay 5400/- and other allowances as per U.P. Government Rules.

3- **Application Fee** :- A non refundable application fee of Rs. 1000/- (Rupees One Thousand only) for Unreserved/OBC candidates and Rs. 500/- (Rupees Five Hundred only) for SC candidates.

### **4- Minimum Qualifications-**

a) **For Allopathic Medical Officer** – A candidate must possess M.B.B.S degree of a University recognized by Medical Council of India. A candidate who possess a post graduate degree/diploma in Medical or Health Service of a University recognized by M.C.I. or being equal. such candidates will be given preference.

b) **For Homeopathic Medical Officer** – A Candidate should have a Bachelor Degree in Homeopathy from a recognised University as schedule of Homeopathy Central Council Act 1973. A candidate who possesses post graduate degree/diploma in medical of Health Services, such candidate shall given preference.

2. Recruitment Process will be subject to the direction of Government of U.P norms.
3. Mere fulfilling of minimum eligibility will not entitle any candidate to be called for Interview.
4. Only matriculation/SSC Certificates issued by the concerned educational board will be considered as proof of date of birth.
5. Candidates belonging to OBC/SC category should submit relevant certificates as per U.P. Government rules.

6. Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement. If a candidate is found ineligible at any stage of recruitment process, he/she will be disqualified and their candidature will be cancelled.
7. Applicants should possess the prescribed qualifications, experience and eligibility criteria as on the closing date of application, as prescribed by the university from time to time for the respective post.
8. All appointments shall be made provisionally subject to verification of certificates and antecedents of the applicant at the time of interview/joining or at any stage during the period of service. In case, it is found at any point of time that any document/information submitted by the applicant is false or the applicant has suppressed any relevant information, the service shall be terminated forthwith without assigning any reason.
9. The University reserves the right to revise/reschedule/cancel/suspend the recruitment process without assigning any reason. The decision of the University shall be final and no appeal in this regard shall be entertained.
10. The University reserves the right of adding or subtracting the number of vacancies.
11. Any Corrigendum/Changes/Updates related to the recruitment process shall be available on official website of University of Lucknow.
12. All supporting documents must be uploaded online on the Samarth Portal of the university. Scrutiny shall be done purely on the basis of the claims and their corresponding supporting documents uploaded on the portal of the university while filling up the form. The filled in application form should be produced during the time of the interview. Candidates have to bring along all the original documents during the interview. **Hard copies need not be submitted.**
13. Candidates desirous of applying for more than one post/category should submit separate applications for each post/category along with requisite application fees.
14. The candidates employed in Government Sectors/Autonomous Bodies must produce the **No Objection Certificates** from their organization/employer at the time of interview with an unambiguous certificate that no vigilance case is pending/being contemplated against him/her.
15. Applications received without the requisite documents, fee or after the prescribed date will not be entertained in any case.
