passenger suddenly fell ill mid-air, prompting the crew to alert the pilot and seek medical assistance at the nearest suitable airport.

IndiGo flight 6E-1054, which departed Bangkok around 8.15pm and was scheduled to reach Delhi at about 11.10pm, was diverted to Lucknow after the passenger's condition deteriorated during the flight, according to airport sources.

The cabin crew informed the pilot about the medical emergency.

The pilot subsequently contacted Lucknow Air Traffic Control (ATC) and sought permission for an emergency landing.

The aircraft landed at Lucknow airport around 11.05pm, sources said.

The unwell passenger was deboarded and shifted to a private hospital in Gomti Nagar for treatment.

LUCKNOW: In vitro fertilisation (IVF) services at King George's Medical University's (KGMU) Queen Mary's Hospital have remained non-functional for more than a year, while the 340-bed facility continues to handle nearly 1,000 outpatient visits a day, exposing gaps in specialised treatment, medicines and basic patient amenities.

The IVF facility, introduced at Queen Mary's in 2009, has remained shut amid issues related to procurement and availability of equipment and consumables.

The prolonged disruption has affected women seeking fertility treatment at one of the state's major government-run maternity hospitals.

KGMU spokesperson Prof KK Singh said efforts were underway to restore the IVF service at the earliest.

Meanwhile, the Queen Mary's Hospital's heavy patient

LDA to release 2,747 mortgaged plots in Sushant

LUCKNOW: The Lucknow Development Authority (LDA) will release 2,747 plots in Sushant Golf City that Ansal Property Infrastructure Limited (APIL) had mortgaged with the authority but later sold without its permission, in a move aimed at protecting the interest of homebuyers who purchased the plots, stated in a LDA official press release on Sunday.

The state cabinet approved the LDA's proposal on September 15, clearing the way for the authority to release the mort-

the registries of the buyers.

LDA vice-chairman Prathamesh Kumar said APIL had mortgaged 3,489 plots with the authority as a guarantee for completing development works in the township. Under the township conditions, the developer could not sell these plots without the LDA's permission. "Ansal sold 2,747 of these mortgaged plots despite the restriction," Kumar said.

The LDA decided against cancelling the registries as doing so would have left genuine homebuyers in uncertainty. The authority will now place its proposal for completing the township before the National Com-

Plots to be released in phases

The LDA will complete development works in the semi-developed and undeveloped parts of Sushant Golf City. It will issue completion certificates sector or pocket-wise and release the mortgaged plots proportionately after completing the required works.

The authority will also allow landowners to seek release of their mortgaged plots before completion if they meet prescribed conditions.

Applicants will have to deposit a guarantee amount equivalent to the fee fixed by the
