**Memorandum of Understanding on

In order to expand scientific and cultural ties between The Islamic Republic of Iran and..... in compliance with the cultural scientific and educational exchange programs concluded by and between the two countries, Allameh Tabataba'i university and ..... agreed as follows;

**Article 1- Areas of the Memorandum of Understanding**

- 1.1. To exchange scientific periodicals
- 1.2. To exchange articles to be published in the related periodicals
- 1.3. To publish books and periodicals jointly prepared
- 1.4. To mutually provide facilities meant for collaboration in scientific activities including but not limited to facilities provided by one party in favor of the other for sabbatical purposes
- 1.5. To exchange professors and students for the purpose of implementing educational /research studies
- 1.6. To hold specialized conferences and to jointly carry out scientific researches
- 1.7. To provide mutual facilities required for sabbaticals
- 1.8. To collaborate in the development of new academic courses
- 1.9. To exchange experiences in various scientific and research fields

**Article 2- Expenses and accommodation:**

- 2.1 The guest university shall bear the travel expenses of guests' teachers and students
- 2.2 Accommodation of guest teachers and students shall be incurred by the host university as the case may be

**Article 3 – Duration and mode of Memorandum of Understanding**

3.1. The manner of commencement and perpetuation of cooperation by and between the two universities shall be decided upon and duly adopted by the representatives appointed by the two universities.


3.2. The instant M.O.U. shall remain valid for four years and may be extended upon the approval by the parties. Each party is entitled to nullify the instant M.O.U. upon submission of a 6 month prior notice to be served to the other party before such time.

**Article 4- Official language and interpretation of the Memorandum of Understanding**

The present M.O.U. comprising four articles, was drawn up and duly signed in two copies, each of the same, having equal validity on the date written first above, in the Persian, .....and English languages , and shall take effect and go into force as of the same date.


