





FEDERATION ARRANGEMENT

The United Nations Educational, Scientific and Cultural Organization (hereinafter called "UNESCO") and the International Atomic Energy Agency (hereinunder called the "Agency"), and represented for this purpose by the Abdus Salam International Centre for Theoretical Physics, Italy (hereinafter called the "Centre") and the

Department of Physics, Faculty of Science, University of Lucknow at Lucknow, India

hereinafter called the "Institute")

Recognizing that frequent and continuing contact between scientists working in related fields is fundamental to the creative process required to ensure the further development of science, as well as its proper application in relation to the requirements of society, and

Recognizing as well the effective role of the Centre in fostering such contact at the international level in respect of the related disciplines of theoretical physics, experimental physics and applied mathematics,

have agreed as follows:

- 1. Scientists of the Institute active in research will visit the Centre at times and for periods to be determined jointly by the Institute and the Centre. Such visitis will coincide with ongoing activities at the Centre which are directly relevant to the field of specialization of the individual scientists concerned. The minimum duration of each such visit will be three weeks.
- Institute, in consultation with the Centre, and this shall be made by the basis so as to permit as many of its staff who are able to do so to benefit from such contact. In making a selection, advice received from the appropriate Institute advisory body will be taken into account. However, as a rule, those selected should be junior members, and in no case older than forty, of the Institute.
- 3. The expenses of visits undertaken in relation to this Arrangement shall be financed on a cost-sharing basis. The Centre shall pay to each scientist in the local currency of the Centre an amount intended to contribute towards daily subsistence expenses. This amount shall be determined by the Centre, and the total amount to be paid for this purpose shall be limited to 150 days for all such visits for the entire period of the duration of the Arrangement. The Centre shall also contribute towards travel expenses of scientists from the Institute to the Centre in an amount not to exceed Euro 620 per person and Euro 2,480 for the total of all such visits. Reimbursements will be made in accordance with the Centre's Travel Standards (see attachment).

- 4. Scientists coming to the Centre under this Arrangement shall not be entitled to any other payment or subsidy from the Centre and the Centre shall not have any liability in the event of death, injury or illness of scientists occurring during their travel or stay in Trieste.
- 5. While the primary purpose of this Arrangement is to make provision for visits to the Centre of scientists from the Institute, the parties to this Arrangement may agree to provide for visits of scientists from the Centre to the Institute. The terms and conditions of such visits shall be the same as outlined above.
- 6. This Arrangement shall enter into force upon signature by the Director of the Centre, on behalf of UNESCO and the Agency, and the authorized representative of the Institute.

When considering the contract for renewal, the Centre will take into account, among other factors, the level and age of the proposed candidates as rell as the necessity to rotate this Arrangement among different institutes in the same geographical area.

7. This Arrangement shall terminate on 31 December 2008 unless extended by the Parties thereto.

GUIDELINES FOR PROPOSALS OF VISITS

Federation Arrangement authorities are kindly requested to submit their proposals for all Abdus Salam ICTP activities respecting the deadlines indicated in the Scientific Calendar. In addition, since the logistic situation of the Centre during the summer months is always particularly critical, it is suggested to avoid as much as possible visits from mid June to mid August, except for fields in which scientific activities are held during these months.

To submit proposals for all visits in 2006 the attached outline should be used. For visits proposed in the following two years of validity of the agreement, the relevant Outline of Proposals will be sent together with the Scientific Calendar of the year in question, as soon as it becomes available. Proposals will be evaluated only if accompanied by Form 1 duly completed in all its parts by the scientists concerned. Each case will undergo a careful screening also in view of the fact that some activities foresee restricted participation. Thus an untimely submission of proposals may preclude the possibility of attendance.

It would be greatly appreciated if the Federation Arrangement authorities would kindly collaborate in avoiding useless work and costs, which may even prevent other scientists from developing countries from visiting the Centre, by ensuring that the Abdus Salam ICTP is notified promptly of any cancellations of approved visits by members of their Institution.
